COMPETITION CONFIRMATION

Figure skating club Koovee, Finland, has the pleasure to confirm the international figure skating competition Koovee Cup 2017.

Event Time:16.-17.9.2017

Venue of Competition: Hakametsä 2 (heated) address: Keltinkatu 2, Tampere, Finland

Competition will be held in the following single skating categories and classes for ISU evaluation:

Advanced Novice Girls (SM-Noviiisit) born 2002-2003

Advanced Novice Girls (SM-Noviiisit) born 2004 and later

SKATERS The list of skaters has been posted on the competition website and is an annex. If an accepted skater cannot compete, please inform the Organiser as soon as possible by e-mail (kilpailusihteeri.koovee@gmail.com)

PLANNED PROGRAM CONTENT The planned program contents for entries if not submitted yet must be sent by e-mail to kilpailusihteeri.koovee@gmail.com immediately.

MUSIC will be played from a CD-player. Discs must be normal CD's, not RW-discs. Music equipped with the full name of the competitor, club and category must be submitted to the announcers' desk before the relevant event and picked up from the same place after the event.

COMPETITION SCHEDULE The preliminary competition schedule can be found on the website. Please note that the schedule is likely still to be modified due to withdraws. The schedule with starting orders will be published on the competition website on 11.9.2017 after the draw.

DRAW: The official draw will be on Monday 11h of September 2017 by ISU Calc program. The result will be published on the competition website immediately afterwards.

ENTRY FEE: Novice A 90e/skaters (SP+FP) for ISU skaters.

Entry fee will be invoiced soon after confirmation and the invoice must be paid latest on due date 15.9.2017

Teams should inform of any changes in their team as soon as possible to kilpailusihteeri.koovee@gmail.com

CANCELLATIONS After 10.9.2017, only cancellation supported with a medical certificate will be refunded.

JUDGES: Skaters are judged by using the ISU judging system. The organizer will invite the judges and pay their expenses. The names of the judges and technical panel will be published on the competition website.

PROTOCOL / LIST OF RESULTS Protocol / list of results will be published on the competition website.

PROTESTS Protests must be submitted to the Referee of the category at the latest 30 minutes after the category. The protest fee is 15 EUR. The referee's decision is final.

AWARDS Three first standings of each category will be awarded with a cup.

EXPENSES: The Organizer does not pay any expenses of the skaters.

LIABILITY According to the ISU Regulations, Rule 119, the organizer accepts no responsibility or liability with respect to bodily or personal injury, property loss or damage suffered by the competitors or officials during the competition.

Participants are expected to have their own insurance. Such insurance must assure full medical coverage and also the return to the home country by air transport or by other expeditious means of the ill or injured person.
